- 1. Maintain their accounts payable, to Origin Micro, Inc., OMI, in a satisfactory and responsible manner.
- 2. Provide hard copy purchase orders to OMI prior to shipment.
- 3. Agree that OMI does not offer warranties, implied or otherwise, on products sold.
Only the manufacturer's warranties apply.
- 4. Agrees rebate payments will be processed no sooner than 45 days past the end of OMI's fiscal year end no later than 90 days past fiscal year end.
- 5. Agrees to forfeit accrued rebates should participant's accounts payables, average days to pay, exceed 10 business days past agreed payment terms as noted on their purchase order as presented to OMI.
- 6. Agrees that the following table represents rebate tiers and that rebates apply back to the first dollar once new tiers have been achieved:

\$750,000/yr	1% vRi
\$1,000,000/yr	1 1/2% vRi
\$2,000,000+/yr	2% vRi

- 7. Rebate period runs concurrent with OMI's fiscal year being August 1 thru July 31.
- 8. Purchases accrue commencing on the date of the acceptance of this form by an Origin Micro, Inc. duly authorized officer, purchase volume requirement will be pro-rated to reflect time remaining in respect to the current **vRi Program** year.
